Session: How to Successfully Navigate a Lodge Merger

Session Length: 45 minutes

Session Description

Mergers are often perceived as scary and viewed in a negative light, and while yes, they can be difficult, they also have the power to bring about something special, something new. This session will discuss tools to help handle a merger. The session will also give participants the chance to speak with someone who has navigated a merger and can speak with experience.

Learning Outcomes

Outcome 1: Understand the emotional aspects of a lodge merger

Outcome 2: Utilize active listening, reframing, and labeling in conflict

Outcome 3: Comprehend the full-scale of the merger process

Theme Connection: Seek New Heights

The merging of lodges allows opportunity for the newest heights to be reached. There is very little in Scouting as new and as capable of reaching unseen heights, as a new lodge.

- What emotions do we feel when going through a merger? – ask room
- Why do these emotions matter in a merger
- Loss Aversion
- Amygdala Hijack

Topic 2 - Tools

15 minutes

Slide 4

- Active Listening

You Said, I Heard

Materials Needed: None

Length of Activity: 5 min

Activity Description: You say a statement like “Will you have that assignment ready by 5:00 tonight.” Ask somebody what they heard the message to be. (ex: You aren’t working fast enough?) Then reframe as you heard “X”, what I meant was “Y”. (ex: I am feeling pressured to get this report in by our bosses.”)

- Reframing
- Labeling

Question and Answer

20 minutes

Slide 5

- Lead a guided discussion based on questions the learners have that will encompass the scale of a merger and that it doesn’t end until well after the lodge has been founded. Also be sure to address as many questions as you can.
